WPATH is excited to announce that registration is now open for our 2021 offering of the **WPATH GEI Online Foundations Course**, scheduled **February 15 – March 28, 2021**. We are excited to make this online learning opportunity available again to those who were not able to join us in 2020.

*The **WPATH GEI Online Foundations Course** will include the following components:*

1. Pre-Recorded Didactic Sessions, **which attendees can stream starting Feb 15, 2021.**
2. Two 2-hour Live Streamed Case Discussion Panels\*, **which attendees will select and attend between March 15 – 28, 2021.**
3. One 2-hour Live Q&A Panel, **which attendees will select and attend between March 15 – 28, 2021.**

Registered attendees will receive the link to access the GEI Foundations Course Platform and begin viewing the **Pre-Recorded Didactic Sessions** on-demand on **February 15th**. When attendees receive this link, they will be prompted to set up an Attendee profile that will be visible to all other Course attendees, Speakers, and Staff.
